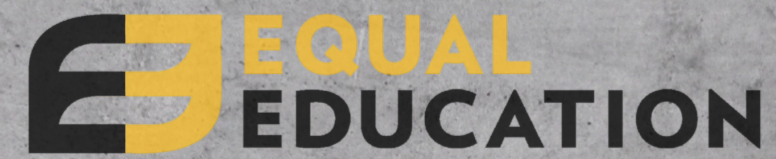

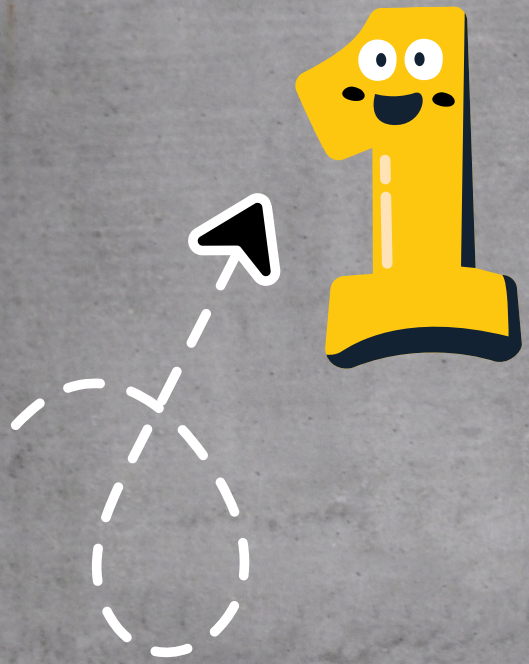

Who is Equal Education:

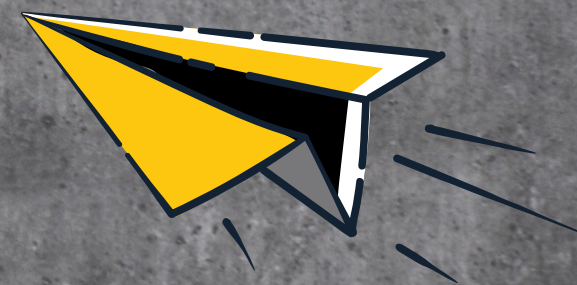

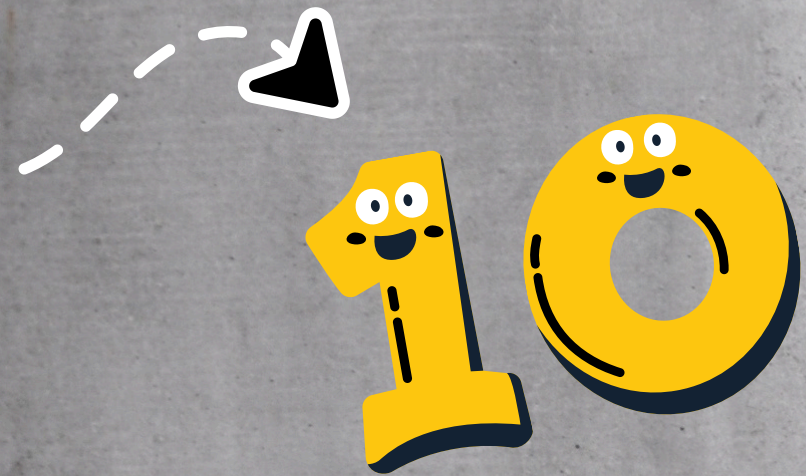




Recommendations for the committee

- The Department of Health, Department of Basic Education, Department of Social Development, and Department of Home Affairs must report statutory rape and related matters once becoming aware; and/or encourage parents and children to report;
- One school – One psychologist, a bare minimum;
- The Department of Basic Education must order a revised round of the National School Violence Study;
- Strengthening of the school-based structure to address violence in school, including the provision of training by respective provincial education departments
